RESOLUTION 2022 - 20

A RESOLUTION OF THE CITY OF STE. GENEVIEVE, MISSOURI STATING INTENT TO PURSUE A FEDERAL LAND ACCESS PROGRAM (FLAP) GRANT IN COOPERATION WITH THE COUNTY OF STE. GENEVIEVE.

WHEREAS, the County of Ste. Genevieve (“County”) has been reviewing various financial options to replace the South Fourth St. bridge due to its deteriorating condition; and

WHEREAS, the County has started work with the Southeast Regional Planning Commission to submit an application for a Federal Land Access Program (“FLAP”) grant; and

WHEREAS, the bridge is part of the street system for the City of Ste. Genevieve (“City”); and

WHEREAS, the City has the bridge replacement in the 10 year Capital Plan with the cost exceeding yearly transportation department revenue projections; and

WHEREAS, South Fourth St. is a main access road for visitors to the National Park Service Ste. Genevieve National Historical Site; and

WHEREAS, visitors and residents must cross South Gabouri Creek to access museums, restaurants, and the unique architecture of the City; and

WHEREAS, the Board of Aldermen (“Board”) agree to administrative oversight of the project if it is approved at the federal level; and

WHEREAS, the Board believes it to be in the best interests of residents and visitors to provide safe access across South Gabouri Creek to the rich history of Ste. Genevieve.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF STE. GENEVIEVE, MISSOURI AS FOLLOWS:

SECTION 1: The staff and officials of the City of Ste. Genevieve are hereby authorized to submit applications, supporting documents and other information as required by the County of Ste. Genevieve and the Southeast Regional Planning Commission.

SECTION 2: The City will work cooperatively with County of Ste. Genevieve utilizing resources provided by the County to prepare necessary documents, engineering, and prior experience to submit a fully prepared application.

SECTION 3: The City agrees to accept management and administration of the project when required due to the bridge being part of the street system.

SECTION 4: City staff and officials are directed to take such action as necessary to implement this Resolution.

SECTION 5: This Resolution is in full force and effect from and after its passage and approval as provided by law.
