

Ste. Genevieve County Commission Minutes

**TUESDAY, JUNE 21, 2022**

22<sup>ND</sup> Day of the April Term. The Commission Met Pursuant to Adjournment. Present were Presiding Commissioner Garry Nelson, Associate Commissioners Karen Stuppy and Randy Ruzicka along with Deputy County Clerk, Michele Gatzemeyer.

THE MEETING WAS CALLED TO ORDER BY PRESIDING COMMISSIONER NELSON AT 8:00 A.M.

THE MINUTES OF PREVIOUS MEETING THAT WAS HELD ON THURSDAY, JUNE 16, 2022 WERE READ. A MOTION WAS MADE BY COMMISSIONER STUPPY TO APPROVE SAID MINUTES AS PRESENTED. COMMISSIONER NELSON SECONDED THE MOTION. ALL IN FAVOR. MOTION PASSED.

Mr. John Donze, Interim R&B Supervisor, appeared before the Commission to provide report for today's meeting as Mr. Schmieder is out on vacation. Following were the items reported:

\*Mr. Donze reported that (2) Call-Outs were necessary on Friday as a result of 'limbs' that were down from high winds during early morning hours.

\*Mr. Donze reported that the R&B Department is in process of doing asphalt patching, mowing, as well as 'fixing' Bad Spots in Road.

\*Update provided on Franklin Bridge. Bridge scheduled to be reopened by Tuesday, 6/21/2022, @ 4:00 P.M. (Commission to confer with Mr. Chris Crocker @ MoDOT for review of 'load rating' of said 'Bridge'.)

\*Information pertaining to RSMo 229.150 as it pertains to 'Ditches and Crossings.....Obstructions or Damages Prohibited' forwarded to local resident that resides on New Church Road.

The Commission reviewed on-going 'issues' surrounding the necessary repairs left as a result of 'cable installation' from 'Spectrum'/'Contractor' (Mastec). It was noted that a 'Bond' is potentially going to have to be reviewed for 'Right of Way' Permitting in an effort to insure that funds are secured for 'repairs' that need to be made.

Local resident appeared before the Commission to request copy of 'Joint Health Ordinance 05162022' as it pertains to 'potential' silica sand operation in 'western portion' of the 'County'.

The Commission reviewed repairs to Fairgrounds. It was noted that there were several items still to be addressed prior to Ste. Genevieve County Fairgrounds. Most notably, there are tires to be 'removed' as well as several 'minor' bleacher repairs. Contact was made with Colin Rogers @ Brockmiller Construction who said that these items would be taken care of within the next several weeks.

Accounts Payable for Date 6/21/2022 for a 'Total' of \$33,133.06 were reviewed and approved for payment by the Commission.

Commission to convene @ 10:15 A.M. to reconvene @ 2:00 P.M. to meet with representatives from 'Spectrum' regarding 'issues' that need to be resolved/addressed in the area of Zell Country Club Estates. Additional details to be provided at Thursday's Commission Meeting to be held on 6/23/2022.
