Mr. Scott Schmieder, R&B Foreman, appeared before the Commission to provide report for today's meeting. Following were the items reported:

\*Mr. Schmieder noted that R&B Department is planning on doing 'culvert work' @ (2) locations this Wednesday &/or Thursday (weather permitting). 1<sup>st</sup> Location is Genevieve Church Road between Burks School Road & Colony Church Road. 2<sup>nd</sup> Location is on Kocher Road approximately (1) mile off Highway 32.

\*AT&T Representative, Jonatan Muniz, to reach out to Mr. Scott Schmieder regarding AT&T 'charge' for damages reported on Jackson School Road. Mr. Schmieder to coordinate w/AT&T due to improper cable installation issues that result in damage.

\*Commissioner Stuppy also noted at this point in the meeting that local resident on Highway 61 reached out as a result of 'damage' sustained from work completed by AT&T. Commissioner Stuppy provided additional information to said 'resident' in effort to resolve matter.

Conference Call was conducted between 'Spectrum' and 'Commission' as it pertains to the many on-going issues that still need to be repaired. Many 'locations' are reported to have been 'completely repaired' by Spectrum; however, Mr. Schmieder noted that he will inspect the same. \*CDBG Chief Development Officer – Working on Project Development.

Accounts Payable for Date 10/10/2022 in the amount of \$59,939.00 were reviewed and approved for payment by the Commission.

Commissioner Stuppy noted that Hutson Glass Company will be completing a final 'walkthrough' at the Courthouse in an effort to insure that we have correct number of windows along with correct measurements regarding the same.
