Tourism update / Upcoming Events – Happy Welch discussed the upcoming events: King's Ball, Chocolate Walk, and the Winter Music Series. Welch went into detail about the upcoming Ste Genevieve Gravel Classic. Audubon's will be the staging area and the starting line will be at Main and Merchant Street. There will be a 10-, 20- and 40-mile race. Vendors should contact Trailnet to coordinate booths.

Holiday Marketing Review - Happy Welch discussed that Google Ads is back to normal after the holidays. Calls are up and searches are down. Audacy (KEZK) did not send their information before the meeting.

NEW BUSINESS

Today was her first day and he introduced her to the State and National Park directors and employees, and they did a tour of the city historic and tourist attractions. Welch said he would advertise for more employees for the Welcome Center.

Re: StG Gravel Race Sponsorship

Issue:

The 2nd Annual StG Gravel Road Race is coming Sunday, April 16, 2023 at 8a starting at Main and Merchant. Trailnet is again organizing the event with help from Kara Burt at Audubon's who will be hosting booths and activities in their parking lot that day.

The City would like to sponsor the race and have negotiated with Trailnet to use half our sponsor dollars to support 7 local vendors with merchant's licenses to set up during the race. Kara has lined up 6 already and a 7th is not far behind. Cost for a booth is \$150 and there will be space for more. The City will also have a booth and will hand out coupons and business information for free for local businesses. The City will also be helping out with barricades, street cleaning, etc.

Recommendation:

Approve \$750.00 from Tourism Tax Commission funds to help sponsor the StG Gravel Road Race.

Sponsor agrees to:

• Provide a high-resolution logo and any relevant guidelines for its use

Pay the Total Sponsorship Amount listed above in full prior to April 16

The Sponsor may:

- Identify itself as a sponsor of Trailnet
- Use the Trailnet logo in accordance with current Trailnet Brand Guidelines when identifying itself as a corporate sponsor of Trailnet
- Issue press releases regarding sponsorship, with Trailnet's approval
- Share complimentary ride voucher coupons with friends, family, clients, and others

Trailnet agrees to:

- Allow the Sponsor to include a mutually agreeable handout or small item in the packets distributed to all registered riders.
- List the Sponsor as a Sponsor on the event registration page and hyperlink to the Sponsor's website.
- Tag the Sponsor in one (1) post on Trailnet's social media accounts in recognition of their sponsorship.
- Invite the Sponsor to host a table at the event Expo
- Offer four (4) complimentary registration vouchers for the 2023 StG Gravel Classic
- Offer seven (7) complimentary Expo sponsorships to local businesses selected by The Sponsor subject to approval by the Sponsee

Additional Terms of Agreement:

- 1. This Agreement expresses the final, complete, and exclusive agreement between Sponsor and Sponsee, and supersedes any and all prior or contemporaneous written and oral agreements, arrangements, negotiations, communications, course of dealings, or understandings between Sponsor and Sponsee relating to its subject matter. If there are any inconsistencies between any exhibit and this Agreement, this Agreement will control.
- 2. This Agreement may be amended only as stated in and by a writing signed by both Sponsor and Sponsee which recites that it is an amendment to this Agreement.
- 3. Sponsee and Sponsor are and will remain independent contracting parties. Nothing in this Agreement creates an employment, partnership, joint venture, fiduciary, or similar relationship between Sponsee and Sponsor for any purpose. Neither Sponsee nor Sponsor has the power or authority to bind or obligate the other to a third party or commitment in any manner. Any use of the term "partner" or comparable term in any communication is solely for convenience.

- 4. Where one party is unable to carry out its obligations under this agreement due to circumstances beyond its control or which it could not have prevented, those obligations are suspended while those circumstances continue, provided the other party is provided reasonably prompt notification and the first party uses reasonable efforts in an attempt to overcome the circumstances preventing its obligations from being carried out.
- 5. Sponsee's sole aggregate liability to Sponsor for a breach of this agreement or arising out of or relating to the transactions contemplated hereby shall in no event exceed the sponsorship amount set forth above.
- 6. The terms and conditions of this agreement shall not be disclosed to any third parties without the prior written consent of both parties.
- 7. The rights of either party under this agreement shall not be transferable or assignable either in whole or in part.
