#### **Staff Report**

Re: State Matching Funds



#### Issue:

State matching funds are available from the Missouri Division of Tourism to match local funds for advertising like radio, TV, billboard, print, and SEM that is done outside of a 50 mile radius and includes their logo or identification.

We have in the past done all of them with most budgets around \$20,000 state/\$20,000 local.

We are currently using the grant to pay for billboards in Kentucky, radio in Cape Girardeau, print in the Missouri Visitors Guide, and Facebook advertising through the state approved vendor.

We estimate we will receive the same funding this year. The board can help us determine where we should put our money in the upcoming state budget year which runs July 1, 2023 to June 30, 2024. Applications open April 1 and will be due by May 31.

#### Recommendation:

Guide us where you would like us to place advertising dollars when we submit for matching grant funds in April.
