Staff

One employee just came back after surgery. Another has gone out on maternity leave. The other out on maternity leave is due back mid-May. We do have five interviews scheduled in a couple of weeks. Kendall will check into a meeting for the four-month-old arrest from a few weeks ago. We want to be sure we have appropriate counseling for those involved with the call.

House Updates

Kendall has slowed down on mowing to keep the lawncare costs lower. He has sprayed the ditch at House 2. It was suggested to mow at a 3.5" cut for healthier grass.

The 911 tax on the ballot did pass. This will help fund the needed 911 upgrades. The marijuana tax also passed in the April election. There is not a dispensary in the County as of yet.

Patient Care

There is an issue with a patient the hospital has been trying to transfer to Carbondale. The transfer has been scheduled and cancelled a couple of times.

House 3 Driveway

Nick Werner met with Sanford Roth of S & R Excavating to discuss the driveway for the new construction of House 3. The driveway will be 40 ft wide and taper in to 25 ft. 25-30 loads of rock will need to be hauled in. Logs and wood are still there but is unable to be gotten out until the driveway and clearing has happened. Sanford has an opening in his schedule as other excavators contacted would be unable to get to us for months. Sanford is willing to dig out the several stumps and do the needed clearing of the lot while he is there installing the driveway.
