### Ste. Genevieve Parks & Recreation Commission Meeting Minutes March 27, 2023 6:30 p.m. City Hall

Meeting called to order at 6:30 p.m. by Gary Roth.

**Roll Call:** Present: Gary Roth, Shelley Schmelzle, Lauren Smothers, Geoff Duval, Mark Buchheit, Barbara Basler-Peterson an Samer Zoughaib. Also Present: Alderwoman Ashley Armbruster, Happy Welch and David Woods. Absent: John Karel and Tyler Weinhold.

**Approval of Minutes:** Lauren Smothers motioned to approve minutes from February 27<sup>th</sup>, 2023. Mark Buchheit 2<sup>nd</sup>. All ayes, no nays, minutes approved.

**Public Works Report:** Geoffrey Duvall reported that the new mowers are in, and mowing will begin next week. The bathrooms were opened today with one minor repair pending.

#### **OLD BUSINESS**

Master Plan Committee Reports.

<u>Fundraising Committee</u> – The kite flying event scheduled for March 25<sup>th</sup> has been rescheduled (due to rain) to April 1<sup>st</sup>. There will be hot dogs, chips, and sodas available for the participants.

#### Trail Committee -

Engineering Costs: Happy Welch explained that the engineering costs will be higher than expected. We have \$7,300 budgeted but the costs are now \$11,900. The state and the city board of aldermen must approve the grant application.

Valle Springs Trail: There was much discussion on the best way to handle trail edges regarding maintenance and appearance. Gravel, landscape edging and sloping edges were all discussed. Fencing and transition areas were also discussed. The board came to a consensus that rock should be placed under the fence and 6" to 1" on the other side would help to reduce weed eating time. Storm drainage issues behind the restrooms was also discussed as well as ADA (Americans with Disabilities Act) compliance. Alliance will be performing the work. Since the park may need to be closed during this work and the work needs to be done when workers are not overburdened with mowing, Mark Buchheit made a motion to table the edging issue. Samar Zoughaib seconded the motion. All ayes, no nays, motion approved.

Playground committee - Had nothing to report.

#### Bathroom committee -

State Bid Information – Happy Welch presented the board with options for precast concrete restrooms that meet state specifications. This project must be done after the trail engineering to ensure elevation compliance with the ADA. It needs to be budgeted for 2024 and needs to be completed by 2026. Alderwoman Ashley Armbruster showed the park board two models on the large monitor. They are both manufactured by CTX. One model is the Cortez which has two bathrooms for \$61,905 and the TAOS which has four bathrooms and a utility closet for \$163,280. Ashley also showed the board options for facades and amenities. Mark Buchheit made a motion to go with the Cortez. Samar Zoughaib seconded the motion. All ayes, no nays, motion approved.

Alderwoman Ashley Armbruster has been working with the Chamber of Commerce on a leadership program scheduled for October 18<sup>th</sup>. That date is subject to change due to weather or park construction.

Lauren Smothers has been in contact with an organization that is amassing labor and funds for a clean up project.

Geoffrey Duvall discussed the rose bushes in front of the park house. They are not healthy and require a lot of maintenance. Samar Zoughaib made a motion to remove the rose bushes and move the crepe myrtles to another location. Lauren Smothers seconded the motion. All ayes, no nays, motion approved.

Motion to adjourn at 7:37 p.m. Samar Zoughaib, 2<sup>nd</sup> Geoffrey Duvall. All ayes, meeting adjourned.

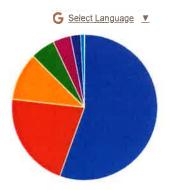

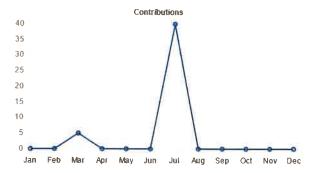
