## **ALL THINGS NEW**

### BY THE NUMBERS

#### ARCHDIOCESE OF ST. LOUIS

- Total Population: 2,259,000
- The City of St. Louis and 10 Counties Franklin, Jefferson, Lincoln, Perry, St. Charles, St. Francois, Ste. Genevieve, St. Louis, Warren, and Washington.
- Number of Catholics: 483,911
- Percent of Population that is Catholic: 21%
- 178 parishes and 6 missions

#### **PRIESTS**

- There are 190 diocesan priests in active parish ministry in the Archdiocese of St. Louis; but after August 1, with many planned retirements, there will be 165 in active parish ministry
- 41% of all diocesan priests are over the age of 70
- 42% of diocesan priests (79 priests) currently serving in parishes are 65 years of age or
- 1/3 of these priests (25) will be retiring this year. Another 53 could retire in the next 10 years.
- Though priests' retirement age is 75, the average age of retirement for our diocesan priests has been 71 because of medical and other reasons.
- If we don't change the way our parishes are configured, by 2025, there would be more parishes than diocesan priests serving in parishes.

- 4132 Baptisms (age 0-6) (2022)
- 3794 Funerals (2022)
- Our baptism and marriage trends reflect the national landscape, as they are half of what they were 20 years ago.

#### **ALL THINGS NEW PROCESS**

- For the last two years, the question we have been asking is "Which parish communities make the most sense to come together in light of demographic shifts, evangelization and social outreach efforts, resources, and priest availability?"
- Compiled sacramental, financial and demographic statistics over the last decade for every parish and school in the Archdiocese of St. Louis
- 70,000 Catholics responded to the Disciple Maker Index survey
- Hosted nearly 350 Listening Sessions for 178 parishes



- Surveyed 18,000 parish school parents, administrators, teachers, staff, donors, community partners, and volunteers
- Met with community, civic and business organizations, held focus groups, and had conversations at the deanery and parish levels, both in groups and one-on-one
- *All Things New* Planning Committee created three consecutive and different draft models, building on feedback from the previous draft model.
- The Priest Council, as required by Church law, provided consultative input to the Archbishop by reviewing all of the data pertaining to each parish that is a part of any of the recommended models involving any potential change.

#### ARCHBISHOP'S DECISION

- Moving forward, the Archdiocese of St. Louis will be reshaped from 178 individual parishes into 134 parishes. These parishes will be overseen by nearly 90 diocesan pastors and 17 religious order pastors. These modifications include the merging of 35 parishes that will be subsumed into neighboring parishes and 15 parishes being merged to create 5 new parishes. There will also be a new personal parish for the Spanish-speaking community in St. Charles County.
- Even in parishes where there is no change to the pastor or parish structure, all of our communities are asked to re-evaluate their current pastoral care, social outreach and evangelization efforts to see if they can be streamlined, refined or re-invented. Our new Vicariate structure will support this.
- Over the next several months our priests will be discerning with their people what the best use of our facilities should be to provide the Sacraments and necessary pastoral care to all who live in their boundaries and begin to reimagine what a vibrant, evangelizing parish ought to look like.
- Implementation of these plans will begin in summer/fall of 2023 and may continue through 2026.

#### APPEAL PROCESS

Any parishioner who claims to have been aggrieved by the Archbishop's decision has
the right to appeal the decision. Per Canon law, the request must be made in writing,
postmarked no later than June 12, 2023, and addressed to the Archbishop at 20

request for appeal.

### **GLOSSARY OF TERMS**

amalgamated/subsumed	when one parish is united to another parish in such a way that the first parish no longer exists and the second parish remains
associate pastor	a parochial vicar, a priest who serves as a co worker with the pastor and pastorally ministers by common counsel and effort with the pastor and under his authority
church	a sacred edifice dedicated for divine worship and to which the faithful have right of entry; the following are also terms commonly used to describe churches: basilica, cathedral, chapel, oratory, shrine, worship site
deanery	a grouping of a certain number of parishes over which is placed a dean who promotes and coordinates common pastoral activity within it
decree	a singular administrative act issued by the diocesan bishop which is required to alter a parish or take other actions in canon law
juridic structure of a parish	the faithful, proper pastor, and finance council of a parish, under the authority of the diocesan bishop
just cause	a legally sufficient reason is needed for the diocesan bishop, after consultation with the diocesan presbyteral council, to erect, suppress, or merge a parish
merged	a parish that has been subsumed into another parish with the latter parish remaining, or two or more parishes that have been united in such a way that a new parish is established from them
mission	a group of the faithful to whom pastoral care is provided but which is not large enough to be established as a parish
multi-parish pastoring	when two or more parishes are entrusted to one pastor; Mass times may change and staff and programs may consolidate
parish church	in a parish with more than one church, the parish church is the one preferentially used for divine worship
parochial administrator	a priest temporarily entrusted with the pastoral care of a parish under the authority of the diocesan bishop in whose ministry of Christ he has been called to share
pastor	a priest stably entrusted with the pastoral care of a parish under the authority of the diocesan bishop in whose ministry of Christ he has been called to share
personal parish	a parish established to serve a group of the faithful determined by reason of the rite, language, or nationality
rector	a priest to whom is entrusted the care of and celebration of the sacraments in a non-parish church

senior priest in residence	a priest who celebrates the sacraments in a church
subsumed/amalgamated	when one parish is united to another parish in such a way that the first parish no longer exists and the second parish remains
suppress	when a personal parish is altered in such a way that it no longer exists; its church remains a sacred edifice open to the faithful
territorial parish	a parish which includes all the Christian faithful of a certain territory
vicariate	a specific part of a diocese entrusted to an episcopal vicar who assists the diocesan bishop in the pastoral governance of that part of the diocese; in the Archdiocese of St. Louis there will be 3 vicariates

A permanent name for the parish will be proposed by the pastor after consulting the faithful of the parish.

A new parish is erected through the merger of Most Holy Trinity Parish in St. Louis, St. Nicholas Parish in St. Louis and St. Teresa and Bridget Parish in St. Louis. The interim name of

Sts. Peter and Paul Parish in St. Louis is suppressed. Sts. Peter and Paul Church remains a sacred edifice. Baptisms and marriages celebrated at Sts. Peter and Paul Church will be recorded at St. Vincent de Paul Parish, the territorial parish in which Sts. Peter and Paul Church is located. All ecclesiastical records of Sts. Peter and Paul Parish will be forwarded to the archdiocesan archives.

St. Stephen Protomartyr in St. Louis has received in an amalgamation the former territory of Immaculate Heart of Mary Parish in St. Louis and St. John the Baptist Parish in St. Louis.

St. Mark Parish in Lemay has received in an amalgamation the former territories of St. Andrew Parish in Lemay, St. Bernadette Parish in Lemay, St. Martin of Tours Parish in Lemay and St. Matthias Parish in Lemay.

A new parish is erected through the merger of Our Lady of Sorrows Parish in St. Louis, Church of the Magdalen (St. Mary Magdalen) Parish in St. Louis and St. Joan of Arc Parish in St. Louis. The interim name of the new parish will be Our Lady of Sorrows, Church of the Magdalen, and St. Joan of Arc Parish. A permanent name for the parish will be proposed by the pastor after consulting the faithful of the parish.

Seven Holy Founders Parish in Affton has received in an amalgamation the former territory of St. John Paul II Parish in Affton.

St. Michael the Archangel Parish in Shrewsbury has received in an amalgamation the former territory of Cure of Ars Parish in Shrewsbury.

St. Mary Magdalen Parish in Brentwood has received in an amalgamation the former territory of Immaculate Conception Parish in Maplewood.


Northern Vicariate - Deanery 2







### FREQUENTLY ASKED QUESTIONS

### What is All Things New?

All Things New is a strategic pastoral planning process where the Archdiocese examines all of our parishes, schools, ministries and agencies, evaluating our effectiveness as a local Church in proclaiming the Gospel and identifying opportunities for improvement and renewal.

The goals are to "make All Things New" by 1) Gospel renewal in our parishes, schools and other ministry efforts, 2) enhancing evangelization efforts to those on the margins of society, and 3) securing a vibrant future for the Church in St. Louis.

This initiative is in response to the call of our Lord to be missionary disciples, and to the Church's desire to "make All Things New" by the Power and Joy of the Gospel.

### Why now?

The landscape of Catholic faithful in our archdiocese looks different today than it did even a few decades ago. This process will allow us to move our ministries forward to meet people where they are-spiritually and geographically-while remaining constant in mission and rooted in faith.

### How is the landscape of the Archdiocese different now than it was just a few decades ago?

Over the last ten years, the number of priests has been declining, the number of Catholics attending Masses has declined, where Catholics live has shifted, the availability of resources has decreased and the need for evangelization and social outreach has increased. #### What was the process behind All Things New?

For the last two years, the question we have been asking is "Which parish communities make the most sense to come together in light of demographic shifts, evangelization and social outreach efforts, resources, and priest availability?"

We compiled sacramental, financial and demographic statistics over the last decade for every parish and school in the Archdiocese of St. Louis.

In addition to the feedback we received from 70,000 parishioners across the Archdiocese through the Disciple Maker Index survey, we hosted nearly 350 Listening Sessions for 178 parishes, surveyed 18,000 parish school parents, administrators, teachers, staff, donors, community partners, and volunteers, met with community, civic and business organizations, held focus groups, and had conversations at the deanery and parish

levels, both in groups and one-on-one.

Our Planning Committee created three consecutive and different draft models, building on feedback from the previous draft model.

The Priest Council, as required by Church law, provided consultative input to the Archbishop by reviewing all of the data pertaining to each parish that is a part of any of the recommended models involving any potential change.

### Who advised Archbishop Rozanski?

In addition to the feedback the Archbishop received from priests, parish and school employees and parishioners, various subcommittees also helped guide the conversation and discernment process:

#### What did Archbishop Rozanski decide?

After prayerful discernment, the Archbishop has decided the following: (information can be viewed in detail at <a href="https://allthingsnew.archstl.org">https://allthingsnew.archstl.org</a>)

- Moving forward, the Archdiocese of St. Louis will be reshaped from 178 individual parishes into 134 parishes. These parishes will be overseen by about 90 diocesan pastors and 17 religious order pastors. These modifications include the merging of 35 parishes that will be subsumed into neighboring parishes and 15 parishes being merged to create 5 new parishes. There will also be a new personal parish for the Spanish speaking community in St. Charles County.
- Even in parishes where there is no change to the pastor or parish structure, all of our communities are asked to re-evaluate their current pastoral care, social outreach and evangelization efforts to see if they can be streamlined, refined or re-invented. Our new Vicariate structure will support this.

- Over the next several months our priests will be discerning with their people what the best use of our facilities should be to provide the Sacraments and necessary pastoral care to all who live in their boundaries and begin to reimagine what a vibrant, evangelizing parish ought to look like.
- Implementation of these plans will begin in summer/fall of 2023 and may continue through 2026.

#### What's next?

Now that decisions have been made regarding parishes and with implementation beginning in August 2023, the Archbishop will begin to look at how the staff of the Archdiocese and social and evangelization outreach efforts can best support the parishes and their ministries. Over the next several months our priests will be discerning with their people what the best use of our facilities should be. Priority will be given to providing the Sacraments and necessary pastoral care to all who live in their boundaries and reimagining what a vibrant, evangelizing parish ought to look like.

### *Is there an appeals process?*

Once the decree is published, anyone who is a parishioner of a parish who considers themselves to be aggrieved (injured or treated unfairly) by the Archbishop's decision has the right to appeal the decision to him in writing concerning the way their parish is being altered. According to the norms of the Church's law (Canon 1734), the written appeal must be made in writing and postmarked no later than June 12, 2023, and addressed to the Archbishop at 20 Archbishop May Drive, St. Louis, MO 63119. We cannot accept emails or phone calls as a request for appeal.

### I think All Things New went too far/didn't go far enough.

The parish is the main place where the faithful have access to pastoral care. Therefore, the diocesan Bishop has to assure that parishes are established and that churches are set up in a way that is equitable throughout the diocese. In all such matters, the Church's law favors preserving the stability of parishes (leaving them as they are).

All the requirements of the Church law seek to assure that the diocesan bishop makes well-informed, prayerfully discerned decisions for the spiritual well-being of the archdiocese, taking into account the needs of the faithful for pastoral care as well as the overall needs of the archdiocese.

### What will happen to the parish buildings that will close?

Pastors will work with their parish communities, Catholic Charities, the Archdiocese of St. Louis and other entities to determine the best course of action regarding any unused buildings on a parish property.

### What will happen to the money parishioners have donated to the parishes that close?

Church law mandates that money donated will go to the parish that subsumes the parish that is closing.

### If two or more parishes merge, which will be the worship site?

Pastors will work with their parish communities and the Archdiocese of St. Louis to determine the best use of the parish buildings as worship sites.

### Will there be any more parish closures or mergers?

Parish communities may work collaboratively to make a recommendation to close or merge their parishes.

### What happens to the parish schools of the parishes that are either merging or closing?

The Archbishop's decision does not immediately affect school operations. The Office of Catholic Education and Formation will work with parishes to continue to discern the future of their parish schools in the months ahead. As we prepare to implement changes regarding the 2024-25 school year, we will also address immediate needs as they arise, and this could include school closures that are unrelated to All Things New.

### What about parish cemeteries?

The Archdiocese of St. Louis has a moral and canonical obligation to care for the dead in perpetuity.

### The Archbishop has also created a new personal parish for the Spanish speaking community. What does this mean for Spanish speaking ministries that currently exist in parishes?

The Archbishop has created a new personal parish for the Spanish speaking community, St. Juan Diego, located at the former campus of St. Barnabas parish. It is important to clarify that the presence of Hispanic ministry in the rest of our parishes should not be discontinued entirely.

Our Episcopal Vicars will be working with our Hispanic community to initiate discussions and foster collaboration to ensure effective ministry to our Spanish speaking brothers and sisters in the St. Charles area.



### TRANSCRIPT OF ARCHBISHOP ROZANSKI VIDEO

As we celebrate the Feast of Pentecost, we recognize the outpouring of the Holy Spirit upon us. In this moment, as I prepare to share the future structure of the Archdiocese of St. Louis, I'm struck by the constant need for Pentecost to happen in our Church each and every day. It is the Spirit that allowed the early Church to move from fear to courage - from silence to bold proclamation of the Gospel. As we have arrived at this moment in the Archdiocese, this indeed is a new Pentecost for us.

I understand the profound impact that a parish community can have on us and how these good and faithful institutions have formed our families. I - of course - grew up in a parish, Sacred Heart of Mary. I received the Sacraments in my parish. I first felt the calling to the priesthood through my parish, and for the first 20 years of my priesthood, lived the life of a priest and pastor in a parish. My heart is with our priests and with you as we become better stewards of the gifts God has given to us.

As your archbishop, I have the duty to provide for the pastoral care of all of the people in the Archdiocese. *All Things New* has called us to ask ourselves what our parishes, ministries and institutions need to look like in order to effectively share the faith that is sustainable for our children and generations to come.

The Archdiocese of St. Louis currently has 178 parishes and 6 missions encompassing the City of St. Louis and 10 surrounding counties. It's a large and diverse territory - urban, suburban and rural. As a significant number of our Catholic population has moved from St. Louis City to St. Louis County and further, we find ourselves with too few priests in large parishes and a disproportionate number of priests in small parishes. For example, in North County we have ten priests ministering to 18,000 Catholics in several parishes. In St. Charles County we have three priests serving the same number of parishioners at one parish.

Our diocesan priests are aging. 41% of active and retired priests are over the age of 70.

And the number of priests is declining. Without these changes, we predict we will have more parishes than diocesan priests serving in parishes by 2025.

Over the past decade, we've also seen fewer people attending Mass. Our numbers *should* be growing. We have more baptisms than funerals. Nearly 1,000 people enter the Church each year. But in 2021, the number of Catholics in the Archdiocese of St. Louis dipped below 500,000 for the first time since the 1960s. As many as 5,000 Catholics are "leaving" the Church or not reengaging in the Church after high school or college every year.

The Church experience in our parishes today is not the same as it was 50 years ago. Yet we are still functioning in many ways out of the same mode of evangelization with the same structures. We have inherited a great treasure of Catholic institutions from previous generations, but many of them are no longer as effective or sustainable as they once were.

Since the beginning of *All Things New*, we have been asking the question "Which communities make the most sense to bring together for collaboration in light of demographic shifts, evangelization and social outreach efforts, resources, and priest availability?"

We gathered feedback about which communities it made sense to be under the care of one pastor. In addition to the feedback we received from 70,000 local Catholics across the Archdiocese, we hosted listening sessions and surveyed school parents, staff, teachers, donors, and community partners. We compiled statistics for every parish and school and met with community, civic and business organizations, held focus groups, and had conversations at the deanery and parish levels, both in groups and one-on-one. I'm grateful for all your feedback and participation.

Beginning in Fall 2022, the *All Things New* planning committee, which includes priests, deacons, parish life coordinators, lay leaders, and religious from across the Archdiocese, reviewed the parish feedback summaries, parish workbooks, and financial data of every parish in the Archdiocese of St. Louis. Using that information, the planning committee refined the first Draft Models to a second set of Draft Models which varied greatly due to the insightful feedback we received. After a final round of feedback from our pastors and Key Parish Leaders, final recommendations were provided by the planning committee and reviewed in great detail by the Priest Council.

I acknowledge this has been a challenging time for many of us. Asking ourselves these questions and changing the landscape of the Archdiocese is uncomfortable. It would be easier *not* to do this. As Archbishop of this incredible community, I wish these changes were not necessary; but, it is what we are called to do at this moment. All the data, input, and feedback affirm this - I would encourage you to look at it if you haven't already. I pray this first phase of work will equip us to build new, creative models of ministry together.

As Pope Francis reminds us, "We are not living an era of change, but a change of era."

Today I share with you the future landscape for the parish structures throughout our Archdiocese of St. Louis. Implementation of these changes will begin as early as August and continue through 2026.

Moving forward, the Archdiocese of St. Louis will be reshaped from 178 individual parishes into 134 parishes. These parishes will be overseen by 86 diocesan pastors and 17 religious order pastors. These modifications include the merging of 35 parishes that will be subsumed into neighboring parishes, and 15 parishes being merged to create 5 new parishes. There will also be a new personal parish for the Spanish-speaking community in St. Charles County.

All of our communities should be re-evaluating their current pastoral care, social outreach and evangelization efforts to see how they can be refined or re-invented, even those parishes where there is no change to the pastor or parish structure.

Our new Vicariate model, with parishes grouped by geographic region, will reinforce this by helping streamline parish support and administration. I am also establishing a new Office of Parish Mission and Vitality that will help me oversee these efforts.

Over the next several months our priests will be discerning with their people what the best use of our facilities should be. Priority will be given to providing the Sacraments and necessary pastoral care to all who live in their boundaries and reimagining what a vibrant, evangelizing parish ought to look like.

My desire is to build a vibrant Catholic presence in every square mile of the Archdiocese for the next century not only by physical structures, but by YOU, the Body of Christ!

Our strategic planning work affects every ministry, agency, office, parish, and entity of the Archdiocese. As we pray our way through these changes, we are all called to work together toward one common mission: to make all things new for the glory of our Risen Lord.

### In support of this:

- I have reached out to parishes with a request that they explore new modes of evangelization. I have asked them to work together and share their resources so we are able to more effectively and efficiently go into our communities and bring Christ to the people in tangible ways. I am edified to already see three parishes in South St. Louis City attending Mass together and collaborating to create a more vibrant Sunday experience, which can lead to evangelization in other areas. These parishioners are delighted to be attending Mass in a full church again!
- I have asked Catholic Charities to work with each parish to expand their direct social outreach services throughout all our counties to provide a more comprehensive communion of care.
- I have established a new Vicariate model that will allow us to place our pastoral service closer to the people and parishes to help foster collaboration across parish boundaries. Parishes are taking a look at their vacant spaces and brainstorming how to use them for the enrichment of their community as a whole. For example, Saints Teresa and Bridget Catholic Church has been renting one of its buildings to the St. Louis Crisis Nursery.
- I have asked our education office to explore possibilities for more comprehensive and accessible Catholic education through the creation of mission schools.
- And I am seeing many of you rising up to take on more responsibility for your own personal faith and service to others. Just in the past few months, 2,000 parishioners across the Archdiocese have participated in our "Evangelization 101" series, empowering them to ignite a new spark of evangelization in their parishes.

In St. Louis, we are called today to start a new chapter in our 200-year history. May a *new* Pentecost set us each ablaze for the Gospel of Christ. We humbly ask the Holy Spirit to guide us, and I hope and pray that we will work together to forge new pathways and ensure that the treasure of our Faith may continue to bring healing and hope to a broken world.

Let us be Steadfast in Faith as we look Forward in Hope.
