BILL NO. 6444 ORDINANCE NO. 6661

AN ORDINANCE AMENDING TITLE 16, CHAPTER 16.04 AND CHAPTER 16.20 OF THE CODE OF ORDINANCES OF THE CITY OF PERRYVILLE, MISSOURI, RELATIVE TO SUBDIVISIONS; AND REPEALING ALL ORDINANCES IN CONFLICT THEREWITH.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PERRYVILLE, MISSOURI, AS FOLLOWS:

Section 1. That Title 16, Chapter 16.04, Section 16.04.020 of the Code of Ordinances of the City of Perryville, Missouri, is hereby amended by amending the definition of "Cul-de-sac" to read as follows:

"16.04.020 Definitions.

* * *

"Cul-de-sac" means a short, local or residential street having one end open to traffic and the other end permanently terminated by a vehicular turnaround."

Section 2. That Title 16, Chapter 16.04, Section 16.04.020 of the Code of Ordinances of the City of Perryville, Missouri, is hereby amended by amending the definition of "Street" at Paragraphs 3, 4, and 5 to read as follows:

"16.04.020 Definitions.

* * *

"Street" means a right-of-way, other than an alley, dedicated or otherwise legally established for public or private use, with a surface, usually affording the principal means of access to abutting property. A street is intended primarily as a means of vehicular travel. The street right-of-way may provide space for public facilities such as sanitary and storm sewers, water, gas, and electric lines, and sidewalks. A street may be designated as a highway, thoroughfare, road, throughway, pike, avenue, boulevard, lane, drive, court or circle. For the purpose of this title, streets shall be classified as follows:

* * *

- 3. Local. The sole function of a local street is to provide access to immediately adjacent property. A cul-de-sac is classified as a local or residential street.
- 4. Residential. A lightly-traveled, low-speed street with limited through traffic adjacent to single-family residences, apartment buildings, or other similar residential structures, or is anticipated to develop as such which may be requested through the planning process and requires the review and approval of the board of aldermen. A cul-de-sac is classified as a local or residential street.
- 5. Marginal Access Street/Service Road. A local street parallel and adjacent to arterials, railroad rights-of-ways, or other barriers, which provides access to abutting properties."

Section 3. That Title 16, Chapter 16.20, Section 16.20.020, Subsection D of the Code of Ordinances of the City of Perryville, Missouri, is hereby amended to read as follows:

"16.20.020 Streets.

* * *

D. Paved streets, with curbs and gutters, shall be surfaced to the following minimum widths, as measured from inside curb lip to inside curb lip: Arterial (four-lane), forty-eight (48) feet; arterial (two-lane), forty-four (44) feet; collector, forty (40) feet; local, thirty-two (32) feet; residential, twenty-five (25) feet; marginal access, twenty-four (24) feet. Alleys, within a business district, shall be surfaced to a minimum of sixteen (16) feet. Cul-de-sac turnarounds shall be paved within ten feet of the right-of-way. In instances where parking will be restricted, the above dimensions can be varied with prior approval of the planning and zoning commission and the board of aldermen."

Section 4. That Title 16, Chapter 16.20, Section 16.20.030, Subsection B of the Code of Ordinances of the City of Perryville, Missouri, is hereby amended to read as follows:

"16.20.030 Curbs and gutters.

* * *

B. Curb construction for concrete pavements shall be integral. The roll-type curbs are permitted on a residential street and may be permitted on additional streets when approved by the planning commission and board of aldermen."

Section 5. That Title 16, Chapter 16.20, Section 16.20.040 of the Code of Ordinances of the City of Perryville, Missouri, is hereby amended to read as follows:

"16.20.040 Sidewalks.

The construction of sidewalks is not normally required in subdivisions, but may be required if the subdivision includes, or is within three hundred (300) feet of existing or proposed schools, playgrounds, or other features which would attract children.

The extent of sidewalks within subdivisions shall be determined by the commission and approved by the board of aldermen. In all subdivisions, the space as specified in <u>Chapter 16.12</u> shall be included in the cross-sectional drawings of streets.

When constructed, sidewalks shall be of Portland cement concrete four inches thick, six inches across driveways, with a minimum width of five feet. "Dummy" control joints shall be placed every five feet and expansion joints shall be placed every forty (40) feet. Concrete shall contain five and one-half sacks of cement per cubic yard and shall have three percent to five percent entrained air. Finish shall be by wood float or broom with all edges and joints tooled. The location of sidewalks shall be as shown in Chapter 16.12.

Where sidewalks are not required, the street grade shall be completed so that additional grading shall not be necessary for any future construction of sidewalks."

Section 6. That Title 16, Chapter 16.20, Section 16.20.080, Subsection B, Paragraph 5 of the Code of Ordinances of the City of Perryville, Missouri, is hereby amended to read as follows:

"16.20.080 Street lighting.

* * *

B. Lighting specifications for major streets in commercial and industrial areas:

* * *

5. Lamps or luminaires shall be an LED equivalent to a one hundred (100) watt minimum high pressure sodium type or that recommended by the city engineer or similar official."

Section 7. That Title 16, Chapter 16.20, Section 16.20.080, Subsection C, Paragraph 4 of the Code of Ordinances of the City of Perryville, Missouri, is hereby amended to read as follows:

"16.20.080 Street lighting.

* * *

C. In residential subdivisions:

* * *

- 4. Fixtures shall be an LED equivalent to a one hundred (100) watt high pressure sodium, mogul base, one hundred twenty (120) volt with photo cell or that recommended by the city engineer or similar official."

 - 3. Section R302.13: Section R302.13 Fire Protection of Floors is hereby deleted in its entirety.
 - 4. Section R304.1: Section R304.1 is hereby added to read as follows:

'R304.4 Minimum area: Every dwelling unit shall have at least one habitable room that shall have not less than 120 SF (11 m2) of gross floor area.'

5. Section R403.1.3: Section R403.1.3 is hereby revised to read as follows:

'R403.1.3 Seismic reinforcing. As set forth in Section 319.203, RSMo, the statutes of the State of Missouri shall control on any issues of seismic design, and any provisions of the code in conflict with the Missouri statutes shall be void.

- A. That a certain document, a copy of which is on file in the office of the City Clerk of the City of Perryville, being marked and designated as the *National Electrical Code (NEC)* 2023, as published by the National Fire Protection Association, be and is hereby adopted as the Electrical Code of the City of Perryville in the State of Missouri for regulating and governing the inspection of electrical installations, investigation of electrical fires, review of plans, drawings, and specifications for electrical systems, and all other related matters concerning the design, alteration, and modification of electrical systems and equipment in the City of Perryville; providing for the issuance of permits and collection of fees therefor; and each and all of the regulations, provisions, penalties, conditions, and terms of said Electrical Code on file in the office of the City of Perryville are hereby referred to, adopted, and made a part hereof as if fully set out herein.
- B. The following sections of the National Electrical Code (NEC) 2023 are hereby revised as follows:
 - Informative Annex H, Section 80.15(G): Informative Annex H, Section 80.15(G) of the National Electrical Code (NEC) 2023 is hereby revised to read as follows:
 - **'80.15(G) Appeal.** Any person shall have the right to appeal a decision or interpretation of the code official to the Zoning Board of Adjustment and may do so in the same manner as provided by Title 17 of the Code of Ordinances of the City of Perryville, Missouri.'
 - 2. Informative Annex H, Section 80.23(B)(3): Informative Annex H, Section 80.23(B)(3) of the National Electrical Code (NEC) 2023 is hereby revised to read as follows:
 - '80.23(B)(3) Persons who shall violate a provision of this code or shall fail to comply with any of the requirements thereof shall be guilty of a misdemeanor, punishable under Section 1.16.010 of the Code of Ordinances of the City of Perryville. Each day that a violation continues after due notice has been served shall be deemed a separate offense.'
 - 3. Informative Annex H, Section 80.25(C): Informative Annex H, Section 80.25(C) of the National Electrical Code (NEC) 2023 is hereby revised to read as follows:

- **'80.25(C) Notification.** If, within three business days after the Electrical Inspector is notified of the completion of an installation of electric equipment, other than a temporary approval installation, the Electrical Inspector has neither authorized connection nor disapproved the installation, the supplier of electricity is authorized to make connections and supply electricity to such installation.'
- 4. Informative Annex H, Section 80.27(A). Informative Annex H, Section 80.27(A) of the National Electrical Code (NEC) 2023 is hereby revised to read as follows:
 - **'80.27(A) Certificate.** All electrical inspectors shall be certified by a nationally recognized inspector certification program accepted by the Board. The certification program shall specifically qualify the inspector in electrical inspections. No person shall be employed as an Electrical Inspector unless that person is the holder of an Electrical Inspector's certificate of qualification issued by the Board, except that any person who on the date on which this law went into effect was serving as a legally appointed Electrical Inspector of the City of Perryville, Missouri, shall, upon application and payment of the prescribed fee and without examination, be issued a special certificate permitting him or her to continue to serve as an Electrical Inspector in the same territory.'
- 5. Informative Annex H, Section 80.27(B)(3): Informative Annex H, Section 80.27(B)(3) of the National Electrical Code (NEC) 2023 is hereby revised to read as follows:
 - '80.27(B)(3) Be well versed in the Code of Ordinances of the City of Perryville relating to electrical work and the *National Electrical Code*, as approved by the American National Standards Institute.'
- 6. Informative Annex H, Section 80.27(B)(4): Informative Annex H, Section 80.27(B)(4) of the National Electrical Code (NEC) 2023 is hereby revised to read as follows:
 - '80.27(B)(4) Have had at least three years' experience as an Electrical Inspector or ten years in the installation of electrical equipment. In lieu of such experience, the applicant shall be a graduate in electrical engineering or of a similar curriculum of a college or university considered by the Board as having suitable requirements for graduation and shall have had two years' practical electrical experience.'
- 7. Informative Annex, H Section 80.29: Informative Annex, H Section 80.29 of the National Electrical Code (NEC) 2023 is hereby revised to read as follows:
 - **'80.29 Liability for Damages.** Article 80 shall not be construed to affect the responsibility or liability of any party owning, designing, operating, controlling, or installing any electric equipment for damages to persons or property caused by a defect therein, nor shall the City of Perryville or any of its employees be held as assuming any such liability by reason of the inspection, reinspection, or other examination authorized.'
- 8. Informative Annex H, Section 80.35: Informative Annex H, Section 80.35 of the National Electrical Code (NEC) 2023 is hereby revised to read as follows:
 - '**80.35 Effective Date.** The National Electrical Code (NEC) 2023 shall be in full force and effect from and after July 18, 2023.'
- C. That all reference to Board of Appeal set out in the National Electrical Code (NEC) 2023 shall mean the Zoning Board of Adjustment of the city.

D. That all reference to the jurisdiction set out in the National Electrical Code (NEC) 2023 shall mean the City of Perryville, Missouri."

Alderman Guth, as Chairman of the Public Works Committee, asks Public Works Director Layton about a tree that was cut down on Mecker. Director Layton tells the Board that the tree was leaning over a shed. He notes that the tree is on city property. City Engineer Baer notes that the city owns a strip of property that widens for maintenance of a sinkhole. City Administrator Buerck notes that our goal is to obtain easements for property rather than purchase property.

Alderman Martin, as Chairman of the Economic Development Committee, asks EDA Director Jones to update the Board on economic development matters.

EDA Director Report:

- Ranken Advisory Board The first meeting of the Ranken Advisory Board that was created per the agreement between Ranken and the City will be held Thursday, August 10th at 8 am at the Ranken Southeast facility.
- Rail Terminal Project We are still moving forward on this project. The engineers have created conceptual drawings and a couple of options on the layout of a potential facility that I will share with the EDA board at our next meeting. The next step is for the engineering firm to create a technical memo with details about the terminal, then create their final report. Once that report is complete, the analysis will essentially be complete. We can then use the analysis to seek funding for construction.
- Youth Entrepreneurship Program (CEO) The steering committee is still in the process of raising the funds needed to move forward with the agreement with Midland Institute. We have some of the funding committed from Wabash Valley Power Alliance.

City Administrator Report:

- MoDot Public Hearing re Chester Bridge July 19 at Catalyst Center 2-4pm Just as an FYI, there is a public meeting on the status and construction updates for the MoDOT Chester Bridge project. It is more of an open house than a public hearing and everyone is invited to attend.
- School Street Lift Station Mo CWC Grants Variance We finally got our official confirmation for the variance we sought. With this in hand, we will work towards installing the main lines first and the lift station the following year.

• **Building Code Updates –** Typically we are contacted regarding our ISO rating before the rate is changed; however, this year we were not contacted. This is why we have read these ordinances as emergency ordinances and will submit them immediately.

City Engineer Report:

- Shared-Use Path The retaining wall is complete. A handrail will be added and the embankment will be shaved back.
- **Soccer Parking Lot –** This project is nearly complete. Plans are underway to restripe the parking lots before soccer practice begins for the season.
- **Sunset Drive –** This project is half-way completed. They plan to pour the last lane in one day. This is the first time Putz Construction has been contracted to perform street construction for the City of Perryville. They are doing a good job.
- **Progress Drive –** The necessary easements, deeds, and agreements have been executed for this project except for the Congregation of the Mission's easement to Wabash, which we expect to be completed soon. The final plans have been submitted to MoDot and all of their comments have been answered and approved. We should be able to bid out this project soon.

City Administrator Buerck asks if the civil inspection on the Ranken parking lot has been completed. City Engineer Baer notes that it has not yet been completed. City Administrator Buerck will check with Robinson Construction and Ranken regarding this matter.

City Attorney Report: City Attorney Pistorio tells the Board that it appears that the City's fine schedule needs to be updated. He also tells the Board that he attended the Missouri Municipal Attorney Association's conference held at the Lake of the Ozarks. He tells the Board that he plans to present updates on certain ordinances based on what he learned at the conference.

Chief of Police Report: No Report.

Parks & Recreation Director Report: PHS athletes will be providing community service in the parks on July 28; the Comic Con event was very successful; the last baseball and softball games of the season were rained out; Parks & Rec League Director Casasola had her baby last week, all are well; Earth Works should be starting the dirt work on the pickleball courts in a couple of weeks.

Alderman Martin notes that it appears that someone is living at the storage sheds on the corner of North West Street and Grand Avenue.

Alderman Amschler notes that the crosswalk on the corner of State and Rolla does not connect to a sidewalk. Public Works Director Layton tells the Board that they will review the area and determine what would be the best way to correct this situation.

Alderman Amschler also asks for an update regarding rocks left in the yards of Dean Elder, Brian L'Hote, and Mike Sutterer from the recent construction project. City Engineer Baer tells the Board that plans are underway to clean out the rock and replace it with grass. City Administrator Buerck notes that the grass planted needs to match the grass that was disturbed.

Now, at this time, upon motion by Alderman Schumer, seconded by Alderman Buerck, it is ordered that the Board now convene into closed session to discuss personnel matters in accordance with Section 610.021(3) RSMo.
