THURSDAY, DECEMBER 21, 2023

25TH Day of the October Term. The Commission Met Pursuant to Adjournment. Present were Presiding Commissioner Randy Ruzicka, Associate Commissioners Karen Stuppy and Mark Marberry along with Deputy County Clerk, Michele Gatzemeyer.

THE MEETING WAS CALLED TO ORDER BY PRESIDING COMMISSIONER RUZICKA AT 8:00 A.M.

THE MINUTES OF PREVIOUS MEETING THAT WAS HELD ON THURSDAY, DECEMBER 14, 2023 WERE READ. COMMISSIONER STUPPY MADE A MOTION TO APPROVE SAID MINUTES AS PRESENTED. COMMISSIONER MARBERRY SECONDED THE MOTION. COMMISSIONER STUPPY YEA. COMMISSIONER MARBERRY YEA. ALL IN FAVOR. MOTION PASSED.

THE MINUTES OF PREVIOUS MEETING THAT WAS HELD ON MONDAY, DECEMBER 18, 2023 WERE READ. COMMISSIONER MARBERRY MADE A MOTION TO APPROVE SAID MINUTES AS PRESENTED. COMMISSIONER STUPPY SECONDED THE MOTION. COMMISSIONER MARBERRY YEA. COMMISSIONER STUPPY YEA. ALL IN FAVOR. MOTION PASSED.

Ms. Kate Becker, Contractor assisting the 'County' presented 'Contract' through 'Tipton Systems' as it relates to 'Service Contract' that applied for 'money counters'. The 'Collector' will have to revisit this in '2024 as 'Contract was negotiated without consult with the Commission'. Signatures were applied as 'Contract' had already been agreed upon; Tipton Services will not release the 'County' at this time from their obligation. The Commission reviewed the 'County Government Legal Services Program/Contract' for '2024 as presented by Schraeder Law Firm. Upon close review of the same, Commissioner Stuppy made a 'Motion' to approve the 'continuance' of said 'Legal Services Agreement' with Ivan Schraeder as legal counsel for Ste. Genevieve County with 'Rate' remaining the same as last year @ \$1,800.00 annually. Commissioner Marberry seconded the 'Motion'. Commissioner Stuppy yea. Commissioner Marberry yea. All in favor. County Clerk, Sue Wolk, presented update surrounding decision made by the Missouri Supreme Court that struck down House Bill 1606, which means that 'Counties' that were allowed to utilize a 'short form' publication of the annual financial statements will be required to 'revert' back to the "long form" publication that will be due March 1, 2024. In addition to this, language was included advising that the potential increase (up to \$14,000) for the Coroner is now gone.
