## Ste. Genevieve County Commission Minutes

## **TUESDAY, JANUARY 23, 2024**

6<sup>TH</sup> Day of the January Term. The Commission Met Pursuant to Adjournment. Present were Presiding Commissioner Randy Ruzicka, Associate Commissioners Karen Stuppy and Mark Marberry along with Deputy County Clerk, Michele Gatzemeyer.

THE MEETING WAS CALLED TO ORDER BY PRESIDING COMMISSIONER RUZICKA AT 8:00 A.M.

THE MINUTES OF PREVIOUS MEETING THAT WAS HELD ON THURSDAY, JANUARY 18, 2024 ARE SCHEDULED TO BE READ AT THE NEXT REGULARLY SCHEDULED MEETING TO BE HELD ON THURSDAY, JANUARY 25, 2024.

Mr. Scott Schmieder, R&B Supervisor, appeared before Commission to provide report for today's meeting. Following were the items reported:

\*Mr. Schmieder provided report on 'icy road' conditions. He noted that roads were 'rough/patchy'. Conditions were rough the further 'North' R&B went.

\*The following roads were 'mentioned' as it relates to 'Potential R&B Projects in '2024'. These were simply 'roads' that have been identified to need attention; no final decisions made. Said roads are as follows:

- \*Becker Road
- \*Bodine Road
- \*Brushy Creek Road
- \*Carron Road 'Original Part' needs to be overlayed.
- \*Coffelt Road Needs 'Repairs'.
- \*Concord School Road
- \*Dogwood Lane
- \*Donze Road 'Original Part' needs to be overlayed.
- \*French Village Road 'Hill' needs attention.
- \*Genevieve Church Road (needs to be overlayed)-Project would have to be completed in 'Sections'.

  - \*Hawn Park Road
  - \*Hickory
  - \*Jackson School Road
  - \*Magnolia Hollow Road
  - \*Minnith Road
  - \*Pleasant Hill Church Road
  - \*Pfeiffer Road
  - \*Roth Cemetery Road

\*Mr. Schmieder noted that 'Three Rivers' Road, Hager Road, & Hart Pinkston Road' potentially need to be overlayed.

\*Misplay & Ditch Roads – Approaches need to be done/would be asphalted. Misplay Road has portions that need 'additional attention'.

\*Portion of Kinsey Road needs repairs.

\*Saline Creek Road/St. Mary Cemetery Road/St. Mary 'Church' Road.

\*Mr. Schmieder noted that questions have been posed surrounding 'Burnt Mill Road'; Perry County Road Department maintains this for Ste. Genevieve County as Ste. Genevieve County maintains 'Holmes Road' for Perry County.

\*Mr. Schmieder also noted that 'slab' needed on East Castor River Road; the 'intent' is that this project be addressed in '2024.

\*The Commission to take 'road trip' for assessment of 'Roads' in an effort to determine which projects can be 'potentially' addressed this year.

\*Fuel Bid Request was handled; Fuel tickets received. (Copy of 'Delivery Tickets' attached to Commission Record Supplement for this Date.)

\*Mr. Schmieder noted that 'Snow Blades' on order for R&B Dept. (This was previously discussed.)

Local resident that resides on Pinkston Road contacted the Commission to advise that 'Road Sign' is missing. Mr. Schmieder still present in meeting and noted that he would 'replace road sign' immediately.

Sheriff Stolzer along w/Jason Schott appeared before the Commission in an effort to review details surrounding the '911 Board/Fund'. County to reach out to legal counsel for the 'County' as well as 'Ste. Genevieve 911 Board' prior to any further movement taken. As additional information becomes available; said detail to be provided.

The '2024 Budget Hearing was held at 9:00 A.M. presented by Sue Wolk, County Clerk – Budget Officer. (Copy presented can be located in Commission Record Supplement for this Date.)

\*GENERAL REVENUE FUND – 12/31/2023 Fund Balance was \$1,888,798.86. Estimated Revenues for '2024 - \$14,502,830.99. Estimated Expenditures for '2024 - \$15,770,369.65. Estimated ending cash balance for 12/31/2024 - \$621,260.20. Upon close review of the same, Commissioner Stuppy made a 'Motion' to approve the General Revenue Budget as presented. Commissioner Marberry seconded the 'Motion'. Commissioner Stuppy yea. Commissioner Marberry yea. All in favor. Motion passed.

\*STE. GENEVIEVE COUNTY R&B FUND – 12/31/2023 Fund Balance was \$1,551,006.07. Estimated Revenues for '2024 - \$4,396,270.00. Estimated Expenditures for '2024 - \$4,963,725.00. Ending cash balance for 12/31/2024 - \$983,551.07. Upon closed review of the same, Commissioner Stuppy made a 'Motion' to approve the County Road & Bridge Budget as presented. Commissioner Marberry seconded the 'Motion'. Commissioner Stuppy yea. Commissioner Marberry yea. All in favor. Motion passed.

\*T.I.F. Fund – Review completed of said fund as presented. Commissioner Marberry made a 'Motion' to approve the T.I.F. Fund as presented. Commissioner Stuppy seconded

No updates to report on Community Center Roof.

State Representative, Dale Wright – 116<sup>th</sup> District – notified the Commission surrounding an initiative which Bob Priddy, historian, is supporting as it pertains to the Steamboat Arabia Museum currently located in Kansas City, MO. The 'initiative' is searching for areas with adequate space to 'house' said museum preferably in 'river town' along Missouri River; however, Ste. Genevieve County was contacted with the knowledge that we are, of course, a river town along the Mississippi River. State Funding is being researched for said project.

Lisa Marschel, Interim Collector, appeared before the Commission to present 'Request to Waive Interest and Penalties' for taxpayer who purchased property in '2023. Tax Bill mistakenly went to 'Escrow Account'; Corrected bill was sent upon this information being discovered.
