Perry County Road Paving Prioritization Study Update 2024

Now at this time, the Commission meets with Jeremy Tanz from SEMO Regional Planning for the presentation of the 2024 Perry County Road Paving Prioritization Study. This study was first done in 2018 and repeated this year. The study reflects Perry County has been hard surfacing gravel roads at a rate of roughly 10 miles per year of the 448 miles of county-maintained roads.

No further action was taken.

Administration Flooring Bid

Now at this time, the Commission considers for approval bids for flooring in the basement of the Perry County Administration Building. One bid was received from Richardet Floor Covering: \$10,334.00.

The Commission approved an areal map of the Legion Lake Bike Trail, asking that it also be sent to Perry County Tourism department for approval before printing. The clerk provided an update on SB190 has been provided. The Clerk provided an update on the utility bill at Emergency Management Department noting a formula would need to be created to evenly split the heating and cooling costs among the agencies housed in the Perry County Health Department building. No further action was taken.
