CITY ADMINISTRATOR REPORT

July 11, 2024

1. The Missouri Department of Transportation approved our TAP application for the sidewalk connection on S. 4th St. We will start the application process for the \$489,065.00 improvement at an 80/20 split with 80% paid for with federal funding.
2. I need a board member volunteer to help with choosing a website developer for city hall. I'm getting a small committee together to review the RFQ submittals that are due Friday, July 12, with the committee meeting next week.
3. The wireless bridge is installed between the street shed and city hall and now are waiting for everything to be programmed and the street phone number to be ported over.
4. Work has begun on the trail at Pere Marquette Park. Alliance has removed the old trail and cleaned the site. Kluesner will be starting concrete work on Wednesday and should be done by early next week depending on weather conditions.
5. The floodgates were closed over the weekend due to flooding predictions based on the Chester gauge. The gates will be reopened possibly on Thursday depending on rainfall during the week and predicted river levels from the National Weather Service.

Received notification that the grant program will open soon. I intend to apply again to try to get some of our handheld radios upgraded. This will be a no matching funds grant, the same as the last 2 DPS grants. Grant has been submitted for approximately \$72,000.

Grant has been approved. **Radios on order anticipate delivery end of the month or first part of next month.**

2024 DPS Grant

Have started the application for no match required grant for truck intercom systems. This is the same grant that we received all of the radio upgrades from. Application is due June 14th. **Submitted**

All ordered equipment is in service, and invoices have been turned over to Sue. Working on the closeout process. **Claim submitted and closing out.**

2024

I will be applying for all new fire hoses and 8 sets of turnout gear in this year's grant request. This is a 50% match which can be in the form of money or "in kind match". We have budgeted for 4 sets of turnout gear and replacement of our 4-inch large diameter hose. If I write these into the grant, the purchases we were planning to make can be used as our match and would only require additional funding of approximately \$6,000.00 that would be available from the rural fire fund. Grant has been submitted. **Have 2 items bid and requesting permission to purchase. The hose will take a little more time before I can bid and request to purchase.**

A RESOLUTION OF THE CITY OF STE. GENEVIEVE, MISSOURI AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH STE. GENEVIEVE COUNTY, MISSOURI, TO UTILIZE CITY HALL AS A POLLING PLACE

WHEREAS, the City of Ste. Genevieve (“City”) received a Polling Place Agreement from the Ste. Genevieve County Clerk (“County Clerk”); and

WHEREAS, the Board of Aldermen wish to continue allowing the City Hall Boardroom as an election polling place and providing access and accommodation as needed.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF STE. GENEVIEVE, MISSOURI AS FOLLOWS:

SECTION ONE. The City Administrator of the City of Ste. Genevieve, Missouri is hereby authorized and directed to execute and enter into a Polling Place Agreement – 2024 with Ste. Genevieve County, Missouri to allow county officials access for election purposes.

SECTION TWO. The City agrees to allow electioneering and campaign signage on its premises as regulated by Section 115.637 RSMo.

SECTION THREE. The portions of this Resolution shall be severable. In the event that any portion of this Resolution is found by a court of competent jurisdiction to be invalid, the remaining portions of this Resolution are valid, unless the court finds the valid portions of this Resolution are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the Board of Aldermen would have enacted the valid portions within the invalid ones, or unless the court finds that the valid portions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.

SECTION FOUR. This Resolution shall be in full force and effect from and after its passage and approval as provided by law.

POLLING PLACE AGREEMENT - 2024

This agreement is between the **Ste. Genevieve City Hall** (hereafter, the “polling place”) and the **Ste. Genevieve County Election Authority** to use its facility, located at:

165 S 4th St, Ste. Genevieve, MO 63670

This agreement will be in effect for all elections and will automatically be renewed annually unless either party gives written notice of termination 60 days in advance of an election.

The polling place will provide voters with the following: access to the building on Monday for set-up before Election Day; access to the building on Election Day from 5:00 a.m. to approximately 8:00 p.m. (or as necessary to complete the voting process). “Access” includes access to parking and restroom facilities; reasonable use of tables, chairs, electrical outlets for voting equipment, etc.; maintenance of a suitable and appropriate level of comfort (heat and air conditioning); and display of official polling place signage, as required by law.

In compensation, the Ste. Genevieve County Clerk/Election Authority will reimburse the polling place in the amount of **\$0** per election and provide Election Day liability for insurance purposes.
