# JOURNAL OF THE BOARD OF ALDERMEN OF THE CITY OF PERRYVILLE, PERRY COUNTY, MISSOURI.

The Board of Aldermen of the City of Perryville, Perry County, Missouri, met at City Hall in said City on the above date in regular session pursuant to adjournment. Present: Larry Riney, Mayor; Seth Amschler, Curt Buerck, Deanna Kline, Douglas K. Martin, Clint Rice, and David J. Schumer, Aldermen; Tracy Prost, City Clerk; and Art Pistorio, City Attorney. Absent: Brent Buerck, City Administrator.

Mayor Riney opens the meeting with the Pledge of Allegiance and invocation.

Mayor Riney now asks for citizens' participation from the floor.

There being no one coming forth, Mayor Riney closes the citizens' participation portion of the meeting.

At this time, Mayor Riney asks if anyone has any questions or wishes to remove anything from the Consent Agenda.

Item 18 - Alderman Schumer expresses his concern regarding the lack of utility design on the preliminary plat of the Schilli Subdivision. Alderman Schumer asks to postpone item #18 from the Consent Agenda until the first meeting after further legal review of the Sewer Development Contract dated July 30, 2024.

Alderman Martin makes a motion to postpone item #18 until the first meeting after further legal review of the Sewer Development Contract dated July 30, 2024. Alderman Buerck seconds the motion, and on vote the motion carries.

Alderman Buerck makes a motion to approve the Consent Agenda with the postponement of item #18. Alderman Schumer seconds the motion, and on vote the motion carries.

At this time, Alderman Kline exits the Council Chambers.

The Board of Aldermen now review the Downtown Revitalization Design Committee's recommendation regarding the 2024-25 TIF Downtown Improvement Grants. Alderman Buerck asks about the grant application and grant review processes. EDA Director Jones tells the Board of Aldermen that the grant cycle had two categories: structural improvements and façade improvements, and the review committee consists of four members from the Downtown Perryville Advancement Board. EDA Director Jones tells the Board of Aldermen that Select Capital Group, LLC, was the only applicant for both the

structural and façade improvement grants. She explains that the recommendation to deny the structural improvement grant application is based on the lack of tax revenue generation and job creation; this aligns with historical decisions made regarding this grant category.

Alderman Rice makes a motion to approve the recommendation from the Downtown Revitalization Design Committee regarding the 2024-25 TIF Downtown Improvement Grants. AN ORDINANCE AMENDING TITLE 2, CHAPTER 2.88, ARTICLE 3, SECTION 2.88.300, OF THE CODE OF ORDINANCES OF THE CITY OF PERRYVILLE, MISSOURI, RELATIVE TO RESIDENCE; AND REPEALING ALL ORDINANCES IN CONFLICT THEREWITH.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PERRYVILLE, MISSOURI, AS FOLLOWS:

Section 1. That Title 2, Chapter 2.88, Article 3, Section 2.88.300, of the Code of Ordinances of the City of Perryville, Missouri, is hereby amended by amending Subsection C as follows:

"2.88.300 Residence.

\* \* \*

C. If all other considerations are equal, persons residing within the city limits of the city of Perryville will be given preference in all appointments of employment. Employees of the city of Perryville shall not have aresidency requirement. However, any prospective on-call employee who does not reside within the city limits of the city of Perryville shall reside within-thirty-five (35) miles and forty-five (45) minutes of their workstation as designated by the city administrator. Active employees who are involuntarily transferred to other positions will not be disqualifiedfrom that transfer or from employment because of distance. Any on-call employee who moves to a new residence more than thirty- five (35) miles and forty-five (45) minutes from their workstation will be placed on probation and granted the opportunity to correct the residency defect in the manner set forth in this section."

Section 2. It is the intent of the Mayor and Board of Aldermen and it is hereby ordained that this ordinance shall become and be made a part of the Code of Ordinances of the City of Perryville, Missouri, and that sections of this ordinance may be renumbered to accomplish such intention.

Section 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

Section 4. That this ordinance shall take effect and be in force from and after its passage and approval.

Section 5. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Mayor Riney asks for Committee Reports.

Alderman Schumer, as Chairman of the Public Works Committee, asks for an update on the erosion efforts on Vincentian Way. City Engineer Baer tells the Board of Aldermen that Fronabarger Concreters is still in the process of maintaining erosion control. The contractor will be reseeding and monitoring the erosion control tubes along the roadway. Alderman Schumer asks Public Works Director Layton for an update on public works matters.

Director Layton tells the Board of Aldermen that the Public Works Department is currently down a trash truck due to an oil and coolant issue. Director Layton informs the Board that replacement trash trucks are in the Capital Improvement Plan (CIP) but no trash trucks have been purchased due to inflation; however, more funds will be allocated in the next CIP to accommodate the increased cost to purchase a trash truck. He shares that, as a result of a trash truck down, some street department workers are working in the refuse department which has delayed the completion of street department tasks.

Director Layton tells the Board that the department is currently filling the gravel holes created as a part of the MAN fiber project with concrete. He notes that Circle Fiber is also working in the city limits and he has been in contact with the Circle Fiber contractor to ensure those gravel holes are patched in a timely manner.

Alderman Buerck requests an update regarding the sidewalk project near Old St. Mary Road and ACE Hardware. City Engineer Baer tells the Board that the sidewalk will be completed by Zoellner Construction, who plans to start next week.

Mayor Riney asks for an update on the patching on Old St. Mary Road relative to the Northeast Outfall Sewer project. City Engineer Baer tells the Board that Schuessler Excavating will be completing the repair to the road soon, after the final testing is completed.

Alderman Martin, as Chairman of the Economic Development Committee, asks EDA Director Jones for an update on economic development matters.

- Industrial Market Analysis Camoin Associates will be in Perryville Monday, October 7, 2024, to conduct site visits for the regional Industrial Market Analysis they're doing for the Perry, Cape, Scott, and New Madrid County region. We will follow up that visit with a group presentation at the Missouri Economic Development Council (MEDC) Fall Conference to share what kind of projects we are working on as a region.
- **Don Welge Memorial Bridge Ribbon Cutting** A group met last week to begin planning the ribbon cutting celebration for the opening of the Don Welge Memorial Bridge. We are hoping to give people the opportunity to celebrate this historic event with many unique activities in collaboration with MoDOT, the State of Illinois, and the city of Chester. We are targeting the May 2026 time frame with quarterly meetings between now and then.

- Warning Siren Activation The automatic siren equipment has been installed and is properly functioning. The attached map and memo provides necessary details for the Board and documents the estimated 5-mile radius around the City's center.
- **Update to Regional CEDS Plan** This serves as an FYI for any of the Board members that may wish to participate in this process. To date, EDA Director Jones and City Administrator Buerck have been involved in both the local and state level planning.
- Fall Cleanup Flyer October 21 25, 2024 Just a reminder for the Board of the dates and process for citizens to request and secure a trash pickup.

- Planning & Zoning Code Update Open House Oct. 10 from 4-7pm at PPC This open house has been scheduled and is being actively promoted, including though an October billing insert for all city residents. The community is encouraged to join us in this important endeavor and provide any input and suggestions they may have.
- Community Foundation Marshall Faulk event Nov. 7<sup>th</sup> from 9-11pm It's hard to believe it was 10 years ago that city leaders along with members of our community worked together to create the Perry County Community Foundation. This year's event will be slightly different than those in the past. There will be no Humanitarian of the Year dinner, instead there will be a reception for foundation supporters that is limited in number. Given the importance of this group and their impact on the community, the city has always participated.
