Ste. Genevieve County Commission Minutes

TUESDAY, JANUARY 21, 2025

6TH Day of the January Term. The Commission Met Pursuant to Adjournment. Present were Presiding Commissioner Randy Ruzicka, Associate Commissioners Cory Ford and Mark Marberry along with Deputy County Clerk, Michele Gatzemeyer.

THE MEETING WAS CALLED TO ORDER BY PRESIDING COMMISSIONER RUZICKA AT 8:15 A.M.

THE MINUTES OF PREVIOUS MEETING THAT WAS HELD ON THURSDAY, JANUARY 16, 2025 WERE READ. COMMISSIONER FORD MADE A MOTION TO APPROVE SAID MINUTES AS PRESENTED. COMMISSIONER MARBERRY SECONDED THE MOTION. COMMISSIONER FORD YEA. COMMISSIONER MARBERRY YEA. ALL IN FAVOR. MOTION PASSED.

Covenant of Indemnification provided to 'County' by Ste. Genevieve County Fair Board. Additional information is being obtained surrounding the same. Additional detail to be provided as it becomes available.

Mr. Scott Schmieder, R&B Foreman, appeared before the Commission to provide report for today's meeting. Following were the items of importance reported:

*Fuel Tickets received by MFA Oil for most recent fuel purchase; MFA Oil had 'low bid'. (Copy of 'fuel receipts' attached to Commission Record Supplement for this Date.)

*Invoice Detail received from Woody's Municipal Supply Company for 'installation of 'Hydraulic Dump Bed' on R&B 1999 'Flat Bed Truck'; approval/motion was made in '2024 for this purchase. Invoice received/approved for amount of \$8,133.00. (Copy of Woody's Invoice #01-38299 attached to Commission Record Supplement for this Date.)

*Mr. Schmieder noted that R&B Department is still waiting on additional 'Quote' for 'Blades'.

*Mr. Schmieder, along with Commission, to perform road inspections in upcoming weeks to assess necessary repairs/improvements to area roads.

*Mr. Schmieder provided 'Equipment Update': He noted that he is awaiting 'cost' of repairs from C&B Diesel for truck being repaired – '2022 'Unit' currently @ Tag Truck Centers for necessary repairs to AGR Cooler.

*Road & Bridge Department continues to clean up 'brush' as a result of recent ice storm.

Commissioner Ford reported on meeting with Crystal Heating & Cooling @ Community Center as it relates to repairs that need to be made to HVAC 'Unit(s)' in "Administration Offices" @ original Community Center structure. (They are also providing estimate for 'Service Contract'.)

*Commissioner Ford meeting with additional contractor on Thursday of this week @ Community Center; additional details to be provided as they become available.

The '2025 'Budget Hearing' was held @ 9:00 A.M. and presented by Sue Wolk, County Clerk/Budget Officer. (Copy presented can be located in Commission Record Supplement for this Date.)

*GENERAL REVENUE FUND - 12/31/2024 Fund Balance was \$1,877,411.08. Expected Estimated Revenues for '2025 - \$15,690,494.60 and Estimated Expenditures for '2025 - \$15,875,305.42. Thus, 'Estimated Ending Cash Balance for 12/31/2025 - \$1,692,600.26. After careful review of said 'Budget', Commissioner Marberry made a 'Motion' to approve the Ste. Genevieve County General Revenue Fund as presented. Commissioner Ford seconded the 'Motion'. Commissioner Marberry yea. Commissioner Ford yea. All in favor. Motion passed.

*COUNTY ROAD & BRIDGE FUND — 12/31/2024 Fund Balance was \$2,214,360.53. Expected Estimated Revenues for '2025 - \$4,789,528.00 and Estimated Expenditures for '2025 - \$5,154,253.00. Thus, 'Estimated Ending Cash Balance for 12/31/2025 - \$1,849,635.53. After careful review of said 'Budget', Commissioner Ford made a 'Motion' to approve the Ste. Genevieve County Road & Bridge Fund as presented. Commissioner Marberry seconded the 'Motion'. Commissioner Ford yea. Commissioner Marberry yea. All in favor. Motion passed.
