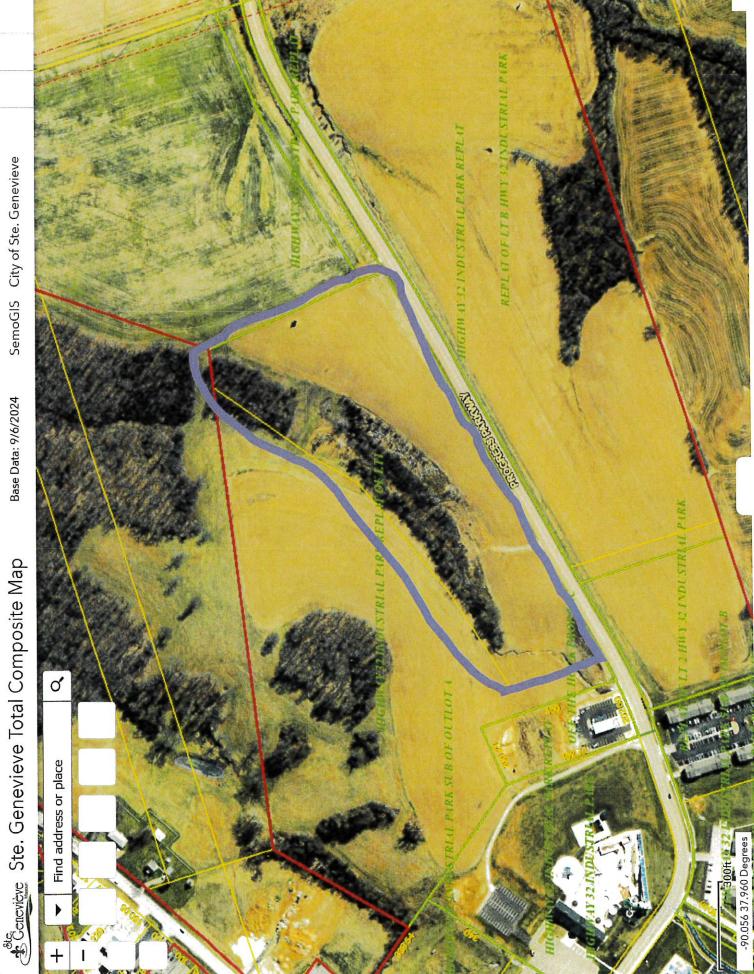

The policy for texting is to send a message using GIS location for items that are not emergencies, such as the water boil advisory for St. Jude subdivision.

Water/Sewer Rate Analysis

Issue:

Carl Brown has completed the rate analysis for Ste. Genevieve with a 140 page report that I will distribute after this meeting for your review.

What I'm distributing here is the basic increase recommendations so you can compare current to the two models that he has created and the reasoning for those scenarios.

If you want a 3rd model then he will do that for a fee for both sewer and water.

Mr. Brown will be meeting with the board during the March 13 work session to review his findings and give you a chance to ask questions.

Issue:

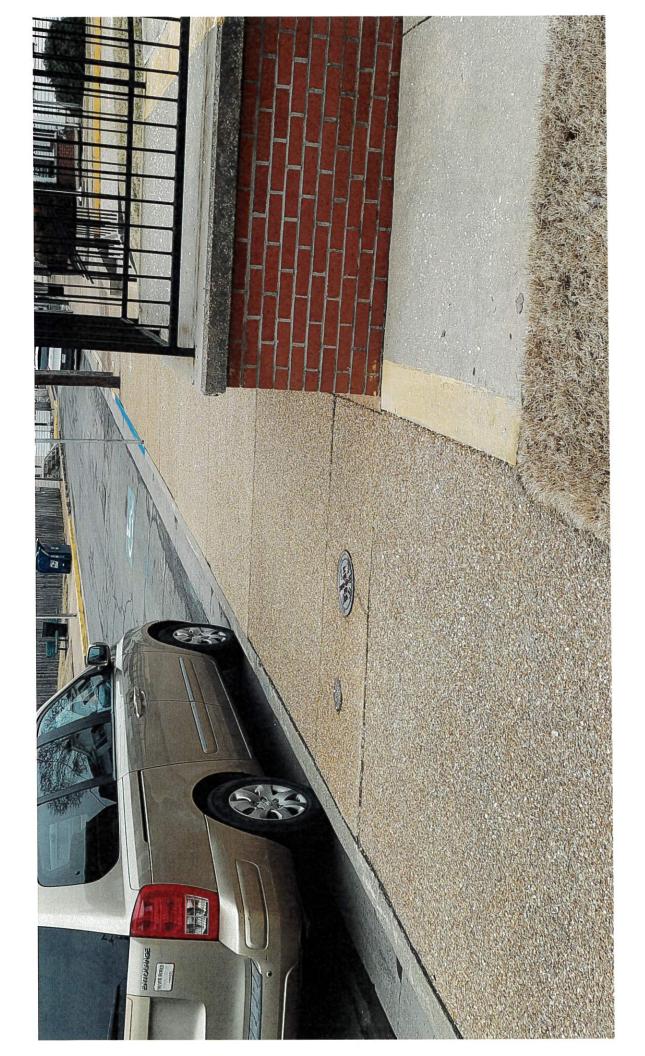
