22nd Day of the April Term. The Commission Met Pursuant to Adjournment. Present were Presiding Commissioner Randy Ruzicka, Associate Commissioners Mark Marberry and Cory Ford along with Deputy County Clerk, Michele Gatzemeyer.

THE MEETING WAS CALLED TO ORDER BY PRESIDING COMMISSIONER RUZICKA AT 8:15 A.M.

THE MINUTES OF PREVIOUS MEETING THAT WAS HELD ON MONDAY, JUNE 23, 2025 WERE READ. COMMISSIONER FORD MADE A MOTION TO APPROVE SAID MINUTES AS PRESENTED. COMMISSIONER MARBERRY SECONDED THE MOTION. ALL IN FAVOR. MOTION PASSED.

Mr. Scott Schmieder, R&B Foreman, was absent from today's meeting. Following were several 'Points of Interest' relating to R&B Department:

*Fuel Supply needed by R&B Department. Most recent fuel supply provided by MFA Oil with the following pricing: "On-Road" Fuel - \$2.952/gallon; "Off-Road" Fuel - \$2.682/gallon. (Copy of 'Bid Requests' attached to Commission Record Supplement for this Date.)

Tap Grant Update – Said project relates to 'Grant Funding' obtained for sidewalks around 'perimeter' of Courthouse as well as 'Sidewalk' from 'Parkwood Drive' to 'Hwy. M' Entrance off Highway 61.

Collector was absent from today's meeting; thus, review of 'Webremit Service Agreement/Software Purchase' tabled until next regularly scheduled Commission Meeting.
