- 1. Call to order by Mayor Pledge of Allegiance to the Flag and Invocation.
- 2. Citizen's participation from floor limited to 3 minutes per speaker. Any person, resident, or non-resident, wishing to address the Board of Aldermen may approach the podium and state their name, address, and comments. Non-residents are invited to speak first, followed by residents of the city. Although we are readily available outside our formal meetings, this will be your only opportunity to offer your thoughts during this evening's meeting as comments from the floor will not be taken during the regular meeting. Although certainly welcome, you are not required to stay for the remainder of the meeting and may exit the Council Chambers in a quiet and respectful manner.

- 5. Approve Pay Request #7 from Centermark Construction, LLC, relative to the Heimos Lift Station project \$106,777.75. (copy)

 The lift station is fully functioning and staff have experienced great relief from the frequent pumping of the previous holding tank.
- 6. Acknowledge City Treasurer Terbrak's memorandum regarding Tax Rate Maximum Authorized Levy. (copy)

 We recently learned that our potential property tax revenue was going to exceed statutory limits, so Treasurer Terbrak worked with the County Clerk to adjust our proposed tax rates downward, limiting our revenue growth to what is allowed by state law. NOTE: The reduction in proposed rates is being offset by the increasing valuation for city properties.
- 7. Approve request to change street closure time for the Taste of Perryville event hosted by the Downtown Perryville Advancement, Inc., from 3:00 p.m. to 10:00 a.m. on Thursday, September 25, 2025. (copy)

This event will play very much like the previous "Farm-to-Table" dinners, with the event from 6 p.m. - 10 p.m. along Jackson Street from St. Joseph to North Street.

- 8. Approve Perry County Heritage Tourism request to close Jackson Street from West Ste. Marie Street to Grand Avenue from 6:00 a.m. to 9:00 a.m. on Friday, September 26, 2025, for the Fireball Run Send Off. (copy)
 - This temporary closure is meant to allow the "fireballers" to safely line up their cars for the start their route the morning they leave town. Once approved, staff will ask a representative from Downtown Advancement to make contact with the individual businesses that are potentially being impacted. NOTE: Originally the request was to close the street in front of City Tavern as well. Staff have worked with the event organizers to reduce the area closed to limit the impact on businesses.
- 9. Approve request from Denise Waller, Coordinator of St. Patrick Center, to host a Thanksgiving meal at the Community Center on Thursday, November 27, 2025, along with access to the Community Center on November 26th for meal preparation. (copy) This event has been well attended and highly supported by the community since beginning over a decade ago. Staff again recommend its approval and we thank Ms. Waller for her and her team's efforts to bring the community together for the holidays.

- 10. Resolution 2025-66 Entering into an agreement with Pollock Landscaping, LLC, relative to the Veteran Memorial Field Fencing Replacement project. (copy) Volunteers from Robinson Construction helped staff put together plans to replace the Veterans Memorial Field fencing and dugouts destroyed by the tornado, preserving the nostalgic feel provided by the wood fencing. Regrettably, the project generated a single bidder (despite multiple inquiries) and their bid was limited to the fence replacement only. Staff recommend proceeding with this bid to replace the outfield fence but will plan to incorporate the dugout carpentry work into a separate, future project, most likely combined with other construction work that must be done.

 This easement was required for the construction and maintenance of the pedestrian bridge connecting downtown to the Catalyst Center.
- 12. Bill No. 6580 for Ordinance No. 6793 Accept easement deed from Moonier-Reddick Post Building Association d/b/a American Legion Post 133 second reading and final passage. (copy)

 This easement was required for the construction and maintenance of the pedestrian bridge, along with an access path to the street, connecting downtown to the Catalyst Center through the American Legion's parking lot.

 This ordinance accepts an easement for the repair and maintenance of a sinkhole.
