ORDINANCES:

Now, at this time, Bill No. 6576, establishing 2025-26 Property Tax Rate re Bond Indebtedness, is read with an emergency clause for the first time upon motion by Alderman Amschler, seconded by Alderman Schumer. On motion by Alderman Amschler, seconded by Alderman Schumer, and on vote carried, Bill No. 6576 is read for the second time. Thereupon on motion by Alderman Amschler, seconded by Alderman Schumer, and on vote carried, it is ordered that the Bill be placed on final passage. Roll call showing the aye and nay vote showed as follows: Seth Amschler, aye; Curt Buerck, aye; Deanna Kline, aye; Kate Martin, aye; Clint Rice, aye; David J. Schumer, aye. Totals: aye, six; nay, none. The Mayor thereupon declared the bill passed and approved and the bill thereupon became Ordinance No. 6789 of the City of Perryville, and is in words and figures as follows:

BILL NO. 6576 ORDINANCE NO. 6789

AN ORDINANCE ESTABLISHING THE AMOUNT OF MONEY NECESSARY TO BE RAISED BY TAXATION DURING THE ENSUING FISCAL YEAR ON THE ASSESSED VALUATION OF ALL PROPERTY SITUATED IN THE CITY OF PERRYVILLE, COUNTY OF PERRY, STATE OF MISSOURI, FOR THE PURPOSE OF PAYING THE BOND PRINCIPAL AND INTEREST FALLING DUE IN THE FISCAL YEAR 2025-26 IN GENERAL OBLIGATION BOND ISSUE INDEBTEDNESS; FIXING THE ANNUAL RATE OF LEVY THEREFOR; AND STATING WHEN THIS ORDINANCE SHALL TAKE EFFECT.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PERRYVILLE, MISSOURI, AS FOLLOWS:

Section 1. That the amount of money necessary to be raised by taxation during the ensuing fiscal year on the assessed valuation of all property situated in the City of Perryville, County of Perry, State of Missouri, for the purpose of paying bond principal and interest falling due in the fiscal year 2025-26 on the General Obligation Bond issue indebtedness of the City is Three Hundred Ninety-Seven Thousand, Six Hundred Thirty-Seven Dollars and Eighty-Six Cents (\$397,637.86).

Section 2. That the total assessed valuation of all property in the City of Perryville, Missouri, as shown by a certified abstract transmitted to the Board of Aldermen by the County Clerk of Perry County, Missouri, is One Hundred Ninety-Eight Million, Three Hundred Twenty-Three Thousand, One Hundred Twenty-Seven Dollars and No Cents (\$198,323,127.00).

Section 3.
