### **END OF CONSENT AGENDA**

At this time, Mayor Riney asks if anyone has any questions or wishes to remove anything from the Consent Agenda.

Item 22 – Alderman Buerck distributes pages regarding King v Moore (Missouri) Enforcement of Minimum Housing Code Standards.

Alderman Buerck makes a motion to approve the Consent Agenda. Alderman Kline seconds the motion, and on vote the motion carries.

At this time, the Board of Aldermen discuss parking ticket fine schedule.

City Administrator Buerck informs the Board that, to the best of staff’s knowledge, the parking ticket fine schedule has remained unchanged since the 1990s.

After discussion, it is the consensus of the Board of Aldermen that staff will revise the parking ticket fine structure to a graduated schedule consistent with current market values.

At this time, the Board of Aldermen discuss vehicle parking in grass.

City Administrator Buerck informs the Board that within the zoning code updates there is a proposed new ordinance to prohibit parking in front yards and asks the Board if they would like to include prohibiting parking on side and rear yards as well.

After discussion, it is the consensus of the Board of Aldermen that the proposed new ordinance with only prohibit parking in front yards.

At this time, the Board of Aldermen discuss Magnolia Street on street parking.

City Administrator Buerck informs the Board that staff has received concerns regarding reduced visibility resulting from on street parking on Magnolia Street.

After discussion, it is the consensus of the Board of Aldermen that staff conduct a traffic study regarding Magnolia Street on street parking.

At this time, the Board of Aldermen discuss mobile home conversion.

City Administrator Buerck tells the Board that this idea was presented by the city of Kirksville, Missouri, at the MML Conference. He shares that city of Kirksville purchased a dilapidated mobile trailer park and partnered with the local trade school to build 800-900 square foot homes ideal for young couples or retirees.

Alderman Schumer shares that he attended this session, and the idea could clean up slum and blight, increase diverse housing stock, and engage local building trade schools. He mentions that the city of Kirksville required the homes to be owner-occupied.

Alderman Schumer, as Chairman of the Public Works Committee, asks staff for an update on the construction along Big Springs Boulevard.

Public Works Director Layton informs the Board that the construction along Big Springs Boulevard is the installation of gas utility to the Perryville Country Club.

Alderman Kline asks staff for an update on the construction along Highway 61 to Sutter Place.

Alderman Kline, as Chairman of the Liaison Committee, informs the Board of Aldermen that the Planning and Zoning Commission has chosen to defer further discussion regarding the special concessions within the Redbud Court Subdivision to the Board of Aldermen.

Alderman Amschler, as Chairman of the Economic Development Committee, asks EDA Director Jones for an update on economic development matters.

- **Downtown Perryville Strategic Plan** - The Perryville Development Corporation agreed to support Downtown Perryville in the matching funds needed to apply for a grant from Missouri Main Street Connection for development of a strategic plan for Downtown. Downtown staff, Alicia Wibbenmeyer, will submit the grant application before the end of October.

- **DNR Director Visiting Perryville** - The director of the Missouri Department of Natural Resources, Kurt Schaefer, will be in Perryville Friday, October 17, 2025, to visit the Environmental Quality Committee, organized by SEMO RPC. I have been reaching out to industry representatives to invite them to attend and meet Director Schaefer.

- **Christmas in the Park** - As budgeted, staff has ordered several strands of lights, hoping to create a driving trail through City Park.

- **Jefferson City Magazine recognizes American Tractor Museum** - Even though the publication is for Jefferson City, page 12 provides a very nice nod for the American Tractor Museum.

- **MPUA recognizes Public Works Director Jeff Layton** - This was a really cool event last week where the Missouri Public Utility Alliance recognized Jeff's efforts during the two storms we had this year. Jeff would be the first to tell you it was a team effort, and is right, but every team needs a captain, and we are happy to have Jeff leading our efforts.

- **ACPA National Award** - Much to our surprise, the City was actually selected for national recognition for the airport runway project. There is an awards ceremony in California in early December but, unless directed otherwise, the City will not be sending a representative.

- **Bikers on the Square Skid Marks** - Staff received pictures immediately from this event which scarred up the street. Staff has talked with organizers and wanted the Board's thoughts on how to proceed. For now, staff plans to let the skid marks wear off, while addressing the issue next year.

- **Key Control** - Administration has asked Jeff and Jim to work on a key control policy. This is particularly important as a single key is used across departments for access to city gates and locks and not everyone returns them when they separate from city employment.

- **Lifeguard Staffing Updates** – The Aquatic Center is doing better with staffing, in part because of the reduced hours but also because of increased incentives and recruiting.

- **Article: St. Louis County Council to Consider Intoxicating Hemp Rules** - This was an interesting story about a county trying to better regulate synthetic drugs that are being sold, in stores very similar to what we are seeing opening here in Perryville,

- **FEMA Tornado Damage Reporting Deadline – October 11, 2025** – All damages the City intends to claim with FEMA must be reported by this date. The project manager has proved a vital team member in helping plan our way forward.

- **PCJJC Dedication** – Monday, October 13, 2025, at 2:00 P.M. - Just a reminder of this brief dedication. It is hoped that the Board is able to join us that afternoon.

- **Chamber of Commerce Annual Dinner** – Thursday, October 16, 2025, at 5:30 P.M. - Checking to see if anyone would like a ticket for this annual event.

- **Moore Cave Celebration** – Friday, October 17, 2025, at 11:00 A.M. - This is a big deal and one that hopefully leads the City to making new friends and partners, particularly with the Ozark Land Trust. The Board is encouraged to join us that morning if they are available. Additionally, we are hosting the director of MoDNR for an "environmental quality" meeting immediately following this event.

- **PHS and St. Vincent Homecoming Parades** - Just wanted the Board to have the dates for both events. The Police Departments stands by ready to support.

- **Propane Bids** – Staff will also post an advertisement for bids for the City’s propane gas.
- **Trailers as Billboards** – City Attorney Pistorio has prepared a legal opinion regarding trailers as billboards which states this is not allowable.

Alderman Buerck recommends sending Airport Site Manager Barbara Maxwell to California for the ACPA National Awards Ceremony.

After discussion, it is the consensus of the Board of Aldermen to send Airport Site Manager Barbara Maxwell to California for the ACPA National Awards Ceremony as the city representative.

City Engineer Report:

- **Heimos Lift Station project** – The contractor will continue to complete final tasks, including fencing, gravel placement, and backfilling.
- **Star St. Sidewalk & Shared Use Path project** – The contractor will continue to complete the items on the punch list such as completing the handrails and seeding.
- **Downtown Events Pedestrian Crossing** – The subcontractor will begin installing the handrails.

City Administrator Buerck asks Baer Engineering to confirm spacing of the bollards and Public Works to install locks on each bollard.

- **Miget Park Trail** – Staff will work to send the bids to MoDOT for concurrence of award. The contractor will most likely begin in Spring 2026.

City Attorney Report: No report.
