 - **Windows & Tuckpointing:** Substantially complete. Done except for a couple of rooms
 - **Media Center:** Pending completion, as some electrical work needs to be finished, a cabinet piece had to be reordered, and a door cylinder is still needed
 - **Roof:** Work ongoing. Although the ladder arrived and was set in place, it did not pass inspection, and additional gas line work and a manufacturer review are still required
 - **Chester Early Childhood Center (CECC):** The door is in place, but the lettering still needs to be reinstalled, with other missing signage on the way. Punch list items are still being addressed, ceiling tiles will be installed over break, the glass is scheduled to ship on January 7th, and expansion joints will be completed over Christmas break
 - **Football Lights:** Project is complete. They are working on the adder
 - **Elevators:** Work is complete; we are still currently awaiting the final inspection
 - **Electricity GS:** As you are aware, we experienced an electrical incident at the Grade School. I am continuing to work with our insurance provider and Brown Electric to determine the final steps needed to fully resolve the issue
